# EFFECTIVENESS OF ENGLISH LEARNING BASED ON ONLINE / E-LEARNING IN STUDENT'S VIEW OF THE UNIVERSITY OF LABUHANBATU

### **Abstract**

This study aims to determine the effectiveness of E-Learning-based English learning. E-learning is an educational system or concept that utilizes information technology in the teaching and learning process. This study uses a qualitative description of research and data analysis. Data was collected using the participant interview method directly by the lecturer to class A students of Labuhanbatu University 2 semester, as many as 38 people. The results of this study can be seen directly how the effectiveness of E-Learning-based in learning English. In fact, the results obtained from the study showed that 18 respondents stated that online learning was less effective, 14 respondents stated that learning was effective, and 6 respondents stated that it was very ineffective. Most students feel that online learning is less effective due to several reasons such as poor network, traffic jams, network errors, when asking students to ask lecturers is less effective. Utilization of E-learning by using teaching strategies, using videos and social media applications such as Instagram and Facebook is considered to be able to foster student interest in learning English.

Most students feel that online learning is less effective due to several reasons such as poor network, traffic jams, network errors, when asking students to ask lecturers is less effective and time feels short due to fluctuating signals. During English class hours, students also find it very difficult to understand the explanation from the lecturer because they use English, the pronunciation is not clear when explaining the powerpoint displayed on the laptop or cellphone screen, students also feel that they do not understand.

It should be realized that online learning of English courses for semester 2A is a problem. Very important components of the online learning process need to be improved and improved. Several teachers and lecturers admitted that online learning is not as effective as conventional learning activities (face to face), because some materials must be explained directly and more fully. In addition, the material delivered online may not necessarily be understood by all students. Based on online teaching experience, this system is only effective for giving assignments, and it is possible that the results of working on these assignments are given when students are about to enter, so it is likely to accumulate.

Observing the experience of some of these teachers and lecturers, the teacher must also be ready to use technology in accordance with the times. Teachers must be accustomed to teaching by utilizing complex online media that must be packaged effectively, easily accessible, and understood by students.

Thus, teachers are required to be more able to design and design online learning that is light and effective, by utilizing appropriate online devices or media and in accordance with the material being taught. Although online learning will provide wider opportunities to explore the material to be taught, the teacher must be able to choose and limit the extent of the scope of the material and the application that is suitable for the material and learning methods used.

The simplest thing that can be done by teachers can be by using Whats App Groups. The Whats App application is suitable for novice online students, because the operation is very simple and easy for students to access. As for online teachers who have more enthusiasm, they can improve their abilities by using various online learning applications.

The solution to this problem can be solved if the government has to provide a policy by opening free online application services in collaboration with internet and application providers to help this online learning process.
